The above school has been given the first recognition for the year 2020-21, from 2021-22 to 2024-25 subject to following conditions, as the school running continuously as per rule 36, 6b of the Karnataka education code, the certificate of renewal of accreditation has been given with the following conditions.

1. Rules of Karnataka Education Act 1983 Karnataka Act 1 of 1995 and circulars and orders issued by the Government and Department from time to time should be strictly followed.

2. Rules 4, 5, 6 and 8 of the Karnataka Educational Institutions, Classification, Regulation and Curriculum Prescribing Rules of 1995 Government Notification No: 116 Misc 95 Dated: 14-11-95 state curriculum shall have school safety and basic amenities.

3. Karnataka education act 1983 Karnataka act 1 of 1995 Karnataka educational institutions, classification, regulation and curriculum fixing rules of 1995 government notification no: ED 116 misc. 95 dated: 14-11-95 tuition fee as per rule 10 only special development charges should be levied and action should be taken as per rule 19(4).

4. The school should be conducted in the medium and at the same place as sanctioned by Section 41 (5) of the Karnataka Education Act, 1983. No transfer and transfer of school will be allowed for 5 years after permission is granted. Usually only one transfer is allowed. If transfer/ handover is desired after this period, fresh registration should be obtained at the new location.

5. Karnataka State Registration of Societies Act 21 of 1960 Order No. 9 of 1957 As in the case of earlier act 13 (up to March 31) should be submitted to the Registrar of Societies and the documents recorded. And the documents of the list of executive committee members of the said organization should be approved and the receipt and approval list should be reserved for review.

6. Education Act 1983 Government Notification ED 131 Misc 98 Dated: 04-11-99 As per sub-rule 2 of accreditation and Director of Secondary Education Circular No: C8 (4) (7) dated 13-12-02 Fixed Fund Deposits at prescribed rates. It should be maintained and renewed from time to time under the joint name of the governing body..

7. Government Order No: ED 44 SLB 2007 dated: 03-09-2007 shall have all the information documents as per the checklist in Annexure 3 and these rules shall be strictly followed.

8. Accounts: Records should be maintained as per the instructions of Government Notification No: ED 74 Miscellaneous 2004 Bangalore Dated: 14-09-2006.

9. Government Order No: ED 113 S.E.S 2005 Bangalore, As per the guidelines Dated: 20th March 2005 Basic facilities, recruitment of teachers and all other facilities should be provided according to the additional departments. As per the departmental rules, there will be qualified and qualified teachers If any teachers is appointed who does not have the prescribed qualification as per the rules, he/she shall be immediately removed and the teacher with qualified qualification shall be appointed, otherwise the same shall be cancelled.

10. Government Notification No. ED.104 S.E.P.2005 for every teaching/non-teaching staff to be recruited in the school. As per instructions dated 12-01-2006 service records containing service details are opened and entries are made and confirmed from time to time.

11. Has it been mentioned in the report that salaries are being paid to the teachers through bank savings accounts as per the government orders and they have ensured that they are not given cash for any reason? Teachers and staff on duty in the school should be provided with service security as per Government order dated 12.01.2006.

12. If the institution has been transferred and the school or change of locality since the commencement of this school, the new registration for the said school should have received first recognition and recognition from time to time as per the Education Act.

13. Commissioner of Police, Bangalore City. According to his Order No: 157/ MAG (1) Other /2014 dated: 26-07-2014 Hon'ble Commissioner of Police should have taken action as per the instructions given to the School Management Boards to carry out guidelines on 09 points in the interest of safety of children in the school.

14. All safety measures should be taken as per rules.

15. R.T.E. The said school should be registered under.

16. No corporal punishment should be given to school children.

17. The installation of fire hydrants should be checked and mentioned in the report.

18. A no smoking notice board should be placed compulsorily within 200 meters of the school.

19. Registration is mandatory for existing schools under the Education Act 1983 came into force and should have been registered.

20. The instructions in the order issued by the Transport Department regarding the maintenance of school vehicles shall be followed.

21. The stairs leading to the upper floors of the school should not be narrow. If there is a safe on each floor If walls are not constructed or very small walls are constructed, precautions should be taken in this regard. Lastly, it should be ensured that there are 5 feet retaining walls. Grilles should be installed so as not to obstruct the ventilation system. This recognition is applicable only if all the above conditions are fulfilled.

22. Teachers must pass the Teacher Eligibility Test (TET) to teach children studying in classes 1 to 5. (Date : 09-06-2014) and the management board should recruit the teachers who have passed the examination.

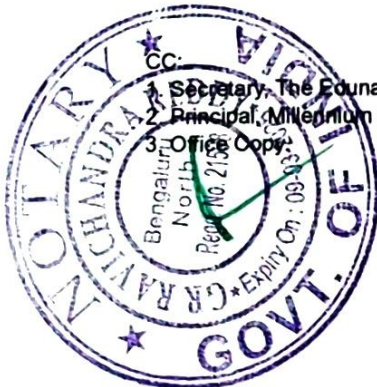
23. School enrolment should start after 1st April every year. This enrolment is mandatory for school children as per the reservation set by the government.

24. Government Circular No: ED/709/PGC/-2017 vide order dated 07-03-2018 and Commissioner's Circular 0:7/(2), 3.5/.../85/2017-18 0.26-03-2018 Subject to the condition of complying with the circular issued by and the provision of online fee payment. And given the first recognition on the provision of deposit, fixed fund, security deposit information.

25. If misleading information is given to the department and there are any disputes, the accreditation will be withdrawn as per the rules and a criminal case will be filed, and the outstanding information will be submitted within a month. In case the accreditation is cancelled immediately.

26. Government Order No: ED 587 PGC 2018 dated 19-11-2018 to review and comply with departmental website of all safety and other measures of the building. If wrong, further action will be taken as per rules.
